Two Application Options:



1. A ServiceMaster representative will visit your location, meet the Restaurant Manager and measure only the tiled floor surfaces where customers or crew walk. This does not include areas under tables or equipment. The application date will be set and the Manager will receive an information sheet outlining their responsibilities and the application process. The areas to be treated will first be mechanically cleaned and then have NO-Slip Treatment applied.

Acid-etching is an invasive process that increases the size of the tile pores allowing dirt, grease and oil to build up and become trapped making it increasingly difficult to clean. In some cases the acid-etched floors need to be replaced and metal fixtures are rusted while the promised slip resistance is short lived
